

**NATIONAL STEPS CHALLENGE™ SEASON 4  
STEP INTO AN ISLAND CARNIVAL WITH COCA-COLA NO SUGAR CHALLENGE  
TERMS AND CONDITIONS**

**Important Notice:** You can only participate in this Challenge once.

**Event Date:** 27 April 2019 (Saturday)

**Event Duration:** 11.00am – 6.30pm

**Venue:** Palawan Green, Sentosa (next to Beach Station)

**Registration Period:** From 5 April 2019 onwards

**1. Eligibility**

- 1.1. You must be a Singapore or Permanent Resident of Singapore, above 17 years old with a valid NRIC or a foreigner with a valid FIN.
- 1.2. Eligible participants who are 17 years of age must obtain parental consent before participating in this Challenge.
- 1.3. You must be a participant of the National Steps Challenge™ Season 4.

**2. Official Challenge Period**

- 2.1. Step into an Island Carnival with Coca-Cola No Sugar Challenge will be held on 27 April 2019.
- 2.2. Registration period starts from 5 April 2019.

**3. Mechanics**

- 3.1 Each eligible participant will be given a game card at registration booth at Palawan Green on 27 April 2019. Last check-in is at 3.30pm.
- 3.2 Follow the instructions on the game card to find and complete the game stations around Sentosa. Each successful activity will give 1 unique stamp.
- 3.3 There are a total of 10 game stations around Sentosa.
- 3.4 Participants with at least 6 completed game stations will receive an exclusive National Steps Challenge™ goodie bag with sure-win prizes and qualify for the Grand Event Draw. Participants with 10 completed game stations will qualify for the Finisher's Draw.

**4. How to Participate**

Participants have to:

**Step 1:** Sign up for "Step into an Island Carnival with Coca-Cola No Sugar Challenge" on the Challenges tab via the Healthy 365 mobile app. Registration starts on 5 April 2019.

**Step 2:** Consent to the Terms & Conditions to complete sign up.

**Step 3:** Check-in on-site and register for a game card at the registration booth at Palawan Green on 27 April 2019. Last check-in is at 3.30pm.

**Step 4:** Complete the game card by visiting the activities located around Sentosa.

**Step 5:** Upon completion of at least 6 stations, you may proceed to the prize redemption booth at Palawan Green to redeem your prize and qualify for the Grand Event Draw. If all 10 stations are completed, you will be eligible to qualify for the Finisher's Draw.

## **5. Sure-win Prizes**

- 5.1. Participants need to submit their game card to the prize redemption booth in order to claim their prizes. Once the game card is verified and sure-win prizes are redeemed, the participant will not be allowed to continue with the challenge.
- 5.2. Participants who completed at least 6 game stations will receive an exclusive National Steps Challenge<sup>™</sup> goodie bag with sure win prizes (i.e. 2 x \$120 Polar Fitness Tracker vouchers and 1 x Coca-Cola Sports Bag).
- 5.3. Sure-win prizes are not exchangeable for cash. There is strictly no refund or exchanges in prizes allowed.

## **6. Lucky Draw Prizes**

- 6.1. A total of 2 on-site lucky draws for the challenge will be conducted.
- 6.2. Participants need to submit their completed game card into the lucky draw box latest by 5.00pm. Once the game card is submitted, the participant will not be allowed to continue with the challenge.
- 6.3. To qualify for the Grand Event Draw, participants must complete at least 6 game stations. This entitles the participant to 1 lucky draw chance to the Grand Event Draw.
- 6.4. To qualify for the Finisher's Draw, participants must complete all 10 game stations. This entitles the participant to 1 lucky draw chance to the Finisher's Draw.
- 6.5. All lucky draws will be conducted in ascending order of prize categories (i.e. lowest value prize to highest value prize).
- 6.6. Eligible participants must be present at the time of draw when their unique serial code or full name or last three digits and alphabet of the NRIC is being called out. If not, the prize will be given to the next winner drawn.
- 6.7. Participants are only allowed to win in 1 prize category for all lucky draws. Eligible participants who qualify but did not win the Finisher's Draw can still qualify for the Grand Event Draw.
- 6.8. Winners will be required to produce their NRIC (or equivalent) as proof of identification. Winners who fail to provide true and accurate information when participating in the lucky draws will be disqualified.
- 6.9. If the prize winners are under the age of 18, the prize must be claimed by their parent or legal guardian.

- 7.4. Eligible participants will also be automatically included in an exclusive Record Breaking Draw for their participation.

## **9. Limitation of Liability**

- 9.1. All Participants of the Step into an Island Carnival with Coca-Cola No Sugar Challenge agree that neither HPB nor their affiliates, employees, directors, officers, agents and/or assignees shall be liable in any way for, and shall be indemnified, released, discharged and held harmless, fully and effectively, by each Participant against and from any and all claims by any Participant or third party for:
- a) Slander, libel, defamation, violation of rights of privacy, publicity, and/or civil rights, depiction in a false light, intentional or negligent, infliction of emotional distress, copyright infringement, and/or any other tort and damages arising from or in any other way related to their participation in the challenge.
  - b) All injuries, losses or damages to property or person of any kind, including death, claims, actions, proceedings and other liability arising out of or caused in whole or in part, directly or indirectly, by the acceptance, possession, use or misuse of the prizes or participation in the challenge.
  - c) Any lost, late, mechanically duplicated, illegible, incomplete, mutilated, tampered, damaged, corrupted or misdirected gamecards; and
  - d) Any losses, costs, expenses, fees or damages incurred by the Participants arising out of or in connection with the challenge or any activity related thereto, including without limitation, any breakdown or malfunction of any computer system or equipment.

## **10. General Terms and Conditions**

- 10.1 HPB reserves the rights to amend the Terms & Conditions without prior notice.
- 10.2 HPB reserves the right to modify and/or terminate the prizes at any time at its sole discretion without any further notice to the participants.
- 10.3 HPB reserves the right at its sole discretion, to suspend, postpone or terminate the challenge or shorten or extend the duration of challenge and/or amend, modify, delete, supplement, replace or revise the T&Cs, without any liability or prior notification to any person, including but not limited to any Participant.
- 10.4 HPB shall not be liable to any party whatsoever for any delay in complying or failure to comply with the T&Cs due to the occurrence of any event or circumstance beyond its control, including without any limitation to, acts of God, natural disasters or catastrophes, riots or wars (whether declared or not), terrorist activities, epidemics, health threats, quarantine requirements, change or issuance of new applicable laws.
- 10.5 HPB further reserves the right to modify and/or terminate the reward scheme of the Challenge at any time at its sole discretion without any further notice to participants.
- 10.6 HPB may, in its sole and absolute discretion and without prior notice, replace, change or substitute any prizes with another of similar value.
- 10.7 HPB reserves the right to disqualify any entries, forfeit any prize or require return of the prize presented to the Participant if:
- HPB, in its sole discretion, decides that the participation is not valid;
  - The Participant does not agree to abide by and be bound by the Terms & Conditions;
  - The Participant is abusive to HPB staff at any point of contact;
  - Participant(s) who failed to provide true, correct and accurate information at any point of contact;
- 10.8 HPB discovers or has reasonable grounds to suspect that the Participant has engaged or attempted to engage in any activity to inappropriately manipulate submission procedures including without limitation the unauthorised use of profiles not belonging to the Participant.
- 10.9 In all circumstances, HPB's decisions shall be final, binding and conclusive on all matters relating to challenge and lucky draw, and no further correspondence shall be entertained. Participants agree and undertake to be bound by the aforesaid decisions.
- 10.10 The T&Cs shall be governed by the laws of Singapore. The T&Cs shall constitute the entire understanding and agreement between the HPB and the Participants. The T&Cs are not intended to confer rights on any third party cap, whether pursuant to the Contracts (Rights of Third Parties) Act (Cap. 53B) or otherwise, and no third party shall have any right to enforce any provision of the T&Cs.
- 10.11 If any term or provision of the T&Cs is held to be illegal or unenforceable, such term or provision shall be deemed to be deleted from the T&Cs and the validity or enforceability of the remainder of the T&Cs shall remain in full force and effect. HPB's failure to enforce at any time

the provisions of the T&Cs or any rights in respect thereto shall in no way be considered to be a waiver of such provisions, rights, or elections or in any way affect the validity of the T&Cs.

10.12 In the event of any inconsistency between the T&Cs and any brochure, marketing or promotional material relating to challenge, the T&Cs shall prevail.

10.13 HPB reserves the right to use the names and photographs of the winners for any promotional, marketing or publicity purposes in any media.
