

NATIONAL STEPS CHALLENGE[™] SEASON 4 SPRING IN YOUR STEP CHALLENGE TERMS & CONDITIONS

Important Notice: This challenge does not involve entry into any of the conservatories within Gardens by the Bay.

Date: 9 and 10 February 2019

Event Duration: 14:00 – 19:00

Venue: Bayfront Pavilion, Gardens by the Bay. Please **check-in on-site at Bayfront Pavilion** (next to the exit of Bayfront MRT Station) from 14:00 onwards.

Directions to Bayfront Pavilion:

- Alight at Bayfront MRT Station (CE1/DT16)
- Take Exit B and follow the underground linkway
- Exit and turn right on Scented Walk towards Bayfront Pavilion



Participant Eligibility

1. This Challenge is only eligible for National Steps Challenge[™] Season 4 participants. Participants must have a valid NRIC/FIN and at least 17 years old and above at the point of registration.
2. Eligible participants who are below 18 years of age must obtain parental consent before participating in this Challenge.

How to Participate

1. Sign up for "Spring in Your Step Challenge" on the Challenges tab via the Healthy 365 mobile app. Pre-registration starts on 21 January 2019.
2. Consent to the Terms & Conditions to complete sign up.

3. Check-in on-site and register for a bingo game card at the National Steps Challenge™ registration booth at Bayfront Pavilion, Gardens by the Bay from 9 – 10 February 2019.
4. Complete the bingo game card by visiting and completing the different activities located around Gardens by the Bay.
5. Upon completion of either 1 or 2 bingo lines on the game card, you may proceed to the National Steps Challenge™ prize redemption booth at Bayfront Pavilion to redeem your prizes and qualify for the Prosperity Draw.

Mechanics

1. Each eligible participant will be given a bingo game card at the National Steps Challenge™ registration booth.
2. Follow the instructions on the bingo game card to find and complete the different activities around Gardens by the Bay to collect stamps, in order to form the bingo lines.
3. There would be a total of 8 activities around Gardens by the Bay. Each completed game station will give you 1 unique stamp.

- Participants must submit their completed bingo game card to the National Steps Challenge™ Prize Redemption Booth, in order to claim their prizes and verify their eligibility for the Prosperity Draw. Once the completed bingo card is verified and prizes are redeemed, the participant would not be allowed to continue with the challenge.
- To qualify for the Prosperity Draw, participants have to submit their completed bingo game card to the National Steps Challenge™ Prize Redemption Booth 15 minutes before the scheduled lucky draw session for verification. For example, if the lucky draw session starts at 16:30, participants must submit their bingo game card latest by 16:15. If not, the participant's lucky draw eligibility would be carried forward to the next available lucky draw session within the same day.
- Each completed and submitted bingo card entitles each participant with only 1 lucky draw chance for 1 lucky draw session throughout the challenge period.
- Participants have to be present at the time of draw and when their unique serial code is announced, in order to claim the prize. If not, the prize will be given to the next winner drawn.
