

## **NATIONAL STEPS CHALLENGE<sup>™</sup> SEASON 4 STANDARD CHARTERED SINGAPORE MARATHON 5KM RUN TERMS & CONDITIONS**

### **1. Challenge Period**

- The Standard Chartered Singapore Marathon (herein referred to as the “**SCSM**”) 5KM Run will officially start on **8 December 2018 7.45 am**.
- Venue of the event will be held at **F1 Pit Building**.
- Duration: 60 – 90 minutes

### **2. Join The Standard Chartered Singapore Marathon 5KM Run**

- Sign up for the SCSM 5KM Run at <https://singaporemarathon.com/nsc5km>.
- National Steps Challenge<sup>™</sup> Season 4 participants enjoy an exclusive rate at \$50 (U.P. \$70) when they sign up for the race. Enter promo code “**NSC5KM**” upon checkout.

### **3. Exciting Line-ups at National Steps Challenge<sup>™</sup> Booth**

#### 3.1 Goodie Bag Redemption

- All SCSM 5KM participants who joined the National Steps Challenge<sup>™</sup> Season 4 are eligible to collect an exclusive National Steps Challenge<sup>™</sup> goodie bag.
- All eligible participants are required to present their NRIC or photo ID at collection point, for verification purposes.
- Participants in the following categories are not eligible for goodie bag redemption
  - a) Anyone who is unable to present their NRIC or photo ID.
