### Mechanics & Prizes

Clock 10,000 steps each day for as many days as possible and incorporate a total of 150 minutes of moderate to vigorous physical activities (MVPA) during the 2-week challenge period and stand to win attractive prizes brought to you by Singapore Airlines Group.

- Only participants of the National Steps Challenge<sup>™</sup> Season 4 are eligible to take part in the Step Up to Take Off with Singapore Airlines Group Challenge.
- Participants who clock the specified number of days of 10,000 steps daily between 10 to 23 December 2018 will be entitled to one (1) lucky draw chance for each prize category, except for Prize Category 1, which is only applicable for KrisFlyer members.
- Participants who incorporate a total of 150 minutes of moderate to vigorous physical activities (MVPA) between 10 to 23 December 2018 will be entitled to an additional one (+1) lucky draw chance for each prize category, except for Prize Category 1, which is only applicable for KrisFlyer members.
- Double (x2) lucky draw chances will be awarded to eligible Challenge participants who are KrisFlyer members (and have submitted their accurate KrisFlyer membership details) by the end of the registration period (22 Dec 2018, 2359 hours). This is only applicable to Prize Category 2 to 5.
- Eligible Challenge participants who are KrisFlyer members (are further given exclusive eligibility to Prize Category 1).
- Participants will be prompted to key in their KrisFlyer membership details via the Healthy 365 mobile app during pre-registration and Challenge period for verification. Participants may be prompted twice, once during the pre-registration period (30 Nov to 9 Dec 2018) and once during the Challenge period (10 to 23 Dec 2018).
- Participants must submit their accurate KrisFlyer membership details via the Healthy 365 mobile app when prompted by 22 Dec 2018, 2359 hours, in order to, be eligible for Prize Category 1 and to be awarded with double (x2) lucky draw chances for Prize Category 2 to 5. Participants who fail to submit their accurate KrisFlyer membership details in the correct format by 22 Dec 2018, 2359 hours will not be considered as a KrisFlyer member in this Challenge.

- Participants who may have keyed in inaccurate KrisFlyer memberships details via the Healthy 365 mobile app would have to amend or resubmit their accurate KrisFlyer membership details via the link shown above by 22 Dec 2018, 2359 hours.

\*Only KrisFlyer members who have submitted their accurate KrisFlyer membership details by the end of the registration period (22 Dec 2018, 2359 hours) are eligible for Prize Category 1.

Winners will be required to produce their NRIC (or equivalent) as proof of identification. Winners who fail to provide true and accurate information when participating in the lucky draws will be disqualified.

1. Sign up for "Step Up to Take Off with Singapore Airlines Group Challenge" on the Challenges tab of the Healthy 365 mobile app by 22 December 2018, 2359 hours.
2. Consent to the Terms & Conditions to complete sign up.
3. Clock 10,000 steps every day for as many days as possible and complete 150 minutes of MVPA from 10 to 23 December 2018 to earn lucky draw chances. Fitness record from the 2-week challenge period must be synced into the Healthy 365 mobile app by 30 December 2018, 2359 hours in order to be considered for the lucky draw.
4. Winners will be announced on [www.stepschallenge.sg](http://www.stepschallenge.sg) and notified by email and phone within 2 weeks from the announcement of winners on our website.
