

Thematic Challenge #3 – Move to The Beat with Jabra (Completers) Challenge

Date: 10 Feb 2018 & 11 Feb 2018 (Every 15mins starting from 11am - 6pm)

Venue: Junction 8 Level 3, Roof Garden

Duration: Est. 30 minutes to complete circuit exercises (timing is inclusive of briefing).

How to Participate?

1. This Challenge is only eligible for Completers of the National Steps Challenge™ Season 2 (NSC2) or Season 3 (NSC3) and they must be between 17-49 years old
2. Time slots given are on a first come first serve basis. Print out or obtain a screenshot of the event ticket after booking your preferred time slot.
3. Pre-registration starts on 2 February 2018.
4. Kindly note that by registering for a timeslot, you will be consenting to the Terms & Conditions of the challenge.
5. Complete a series of static exercises with the Jabra Elite Sport earbuds.
6. Receive your lucky draw chance and 2 Timezone play chances upon completion of exercises.

Mechanics

1. Each participant will be given a set of Jabra Elite Sport earbuds*.
2. Perform a series of exercises as instructed through the Jabra Elite Sport earbuds.
3. The static exercises will be timed by our stationmasters.

- Participants from the completers challenge can also participate in the main challenge.
- HPB reserves the right to turn down participants on site who are non-completers even if they did successfully reserve a time slot online.

- Participants must turn up 15mins before their selected time slot. Failure to do so will result in their time slot being forfeited.
