

Terms and Conditions for “Celebrate this festive season with a bonus \$2 eVoucher” Promotion

The following terms and conditions, and all subsequent revisions or amendments made by the organiser, Health Promotion Board (“HPB”), shall apply to the “Celebrate this festive season with a bonus \$2 eVoucher” Promotion (“Promotion”).
